# RAILROAD HERO HONORED

Our own member, <u>C. J. Keenan</u>, on November 7<sup>th</sup> personally presented to Senor Adolpho Mateos, President of Mexico, a certificate honoring the election of Mexican citizen, Jesus Garcia to the National Railroad Hall of Fame.

Some 40 years ago Jesus Garcia was an employee of the Nacozarc Railroad between Agua Prieta, Sonora and the mining town of Nacozari—a train of dynamite in the yards at Nacozari caught fire and could not be extinguished—Jesus Garcia sensing the situation climbed aboard the engine, coupled on and headed out of town with the cut of cars which blew up far enough away from town to save the citizens and the town of Nacozari. Jesus Garcia was killed in this act of heroism. Mexico has delared

November 7 a national holiday in honor of railway hero Jesus Garcia. The Nacozari Railroad is the only railroad property in Mexico which is still owned by Southern Pacific.

# ROGER CORBIN'S NEWS

Received a very newsy letter from Roger Corbin with the following news which he thought you would all like to hear: We quote from his letter, "First of all, on the Rayonier Inc. – in the last few months Rayonier has sold loco's No. 2, 90, and 70. This leaves Nos. 110, 120, 14 and 38 all steam at Railroad Camp. Engine #2 went East; #90 to Tillamook (which is still at the terminal yards in Portland); and #70 is going to the P. S. & S. U. Ry. At Snoqualmic, Washington.

"Here at Centralia at the Eastern Ry. an old logging line that shut down 1949 part of it is being scrapped. The part that is around the shop was left as is until now. Quite a few of the logging flat cars are gone, but I believe the two old rusty shays are still inside the shop.

"Near Chehalis on the Chehalis Western R. R. Weyerhauser has moved their logging camp from camp McDonald to Pe Ell and have torn up about 9 or 10 miles of Railroad from Milburn to Camp McDonald. The NP uses NP track from Milburn to Pe Ell."

# THIS AND THAT

NP to Launch Faster Service - A faster westbound freight service which will cut a full day from the running time between Chicago and Portland will be initiated by the Northern Pacific railway beginning October 27, officials of that railroad announced. The new service will provide third evening arrival for forwarder traffic and other important carload shipments. The faster scheduling will be achieved by accelerated movement of freight on the Burlington from Chicago to the Twin Cities as well as a speed up of the freight movement on the NP west of Minneapolis and St. Paul, NP officials said.

Corvallis G. T. 10-19-63- Old Depot, Houses Scheduled for Sale - Among buildings scheduled to be sold to clear right of way for the new Harrison St. bridge is the old OE depot, located just east of the Van Buren Street bridge and which for many years served as a crew house for Oregon State University oarsmen. The old ex-depot is the last surviving relic of the railroad. The former road bed can no longer be easily traced and a mile or so of trestle north and east of the depot that kept the tracks above the then-annual Willamette river floods have long since disappeared.

<u>PUC Loses Traction Battle</u> - The Oregon Supreme Court refused 4-3 to assess any penalties to assess any penalties against the Portland Traction Co. for abandoning passenger service on Nov. 25, 1957. This should be the last chapter in the long court battle. The company operated interurban service between Portland, Oregon City, and Bellrose. Former Public Utility Commissioner Howard Morgan ordered the company to restore service. But the company never had to because the Supreme Court ruled Morgan's order unconstitutional. It was rescinded 13 months after the service was stopped. The PUC then brought suit to collect a \$10,000 penalty for the failure of the traction company to provide service during that 13 months.
