Tacoma's Plan for Mountain Train Getting on Track

Tacoma's Train to the Mountain is about to round several treacherous bends - bends that once threatened to derail the project.

As part of a proposed publicprivate partnership that includes The Boeing Co., the City of Tacoma is on the verge of acquiring the Chehalis Western Railroad from Weyerhaeuser Co. for \$3.25 million.

The deal, if approved by the City Council and the Port of Tacoma commissioners, will clear some major obstructions to the city's long-sought passenger train to Mount Rainier.

It also will allow the city to operate common-carrier freight service to the port's growing Frederickson industrial area, which will help underwrite the excursion train. Common-carrier service is non-private service governed by Interstate Commerce Commission regulations.

As an added bonus, commoncarrier status will qualify the city to apply for federal and state rail funds, which would defray the estimated \$6 million cost of repairing sections of badly decayed track. Dollars are available to repair only non-private freight track - but no one stops you from running a Train to the Mountain over the same rails.

The city will operate the railroad as the Tacoma Eastern Railway co., a name that dates back to the 1890s.



"Now, we have a complete link," said Nancy Forster, assistant to the city manager and the city's Train to the Mountain point person. "We really couldn't have done it without our partners."

Those partners include the port, which will join with the city to provide one-third of the purchase price. The Boeing Co., along with Tukwila developer M.A. Segale, will kick in another one-third of the price. The Rail Division of the State Department of Transportation will put in the final third, Forster says.

Boeing will benefit from economical common-carrier freight service to its Frederickson plant. Segale, whose previously announced bid to buy the Chehalis Western from Weyerhaeuser fell through, will buy the railroad's 90acre former repair and maintenance facility in Thurston County. He also preserves the capability of moving gravel from one of his companies by rail. Map from Tacoma newspaper showing route of new Mt. Rainier train. The amount of rail repair money for which Tacoma can apply will be based on a cars-per-year-per-mile formula. The more freight Tacoma Eastern hauls, the greater its freight revenue and potential track repair money.

Forster says the city already has talked with "roughly five or six potential customers, some possibly substantial users of the line." Boeing is a modest user on that list.

Highlights from the 1994 Board of Directors Meeting

(from Pittsburgh Chapter, August, 1994)

The Society's Board of Directors met on June 24, 1994 in Atlanta, Georgia. A preliminary count was (75) voting directors present with a total meeting attendance of (111). Although only ten weeks had elapsed since the Spring meeting, there were several significant developments. Here is a summary of some of the things that happened.

The first annual report to the members has been assembled for publication in Bulletin #3. It covers our financial results and other accomplishments for the previous fiscal year. Comptroller Bob Heavenrich reported that financial results for the current year also look solid, with income slightly above projections and most spending well within budget.

A Bylaws Committee has been appointed to study the term limits issue discussed in St. Louis. Board members with specific ideas and proposals should send them to C. Alex Rose, General Counsel, 400 West Market Street, Suite 700, Louisville, KY 40202-3358.

The Nominating Committee presented their nominations for elected offices. The Committee's nominations are listed on the reverse of this report. Note that there are currently two candidates for National President. VP-Public Relations Dick Simons has decided to retire from that position, and Secretary Greg Molloy declined renomination in order to run for President. In addition, Regional Vice Presidents Al Howe (Central) and Pete Hasler (Metropolitan) declined to run this year. As always, nominations remain open through September 15.

The 1994 Railway Heritage Grant awards were announced. Bucktail Chapter received \$2,000.00 toward replacing tubes and flues in their Shay locomotive. Connecticut Eastern Chapter received \$1,500.00 toward restoration of a 1906 NYNH&H wood baggage car. Bluewater Michigan Chapter received \$2,000.00 toward their project to restore their dining car "Silver Lake" to its original GTW appearance.

In Convention news:

- Attendance at the 1994 Atlanta Convention was below expectations, with fewer than 1,000 people registered, and ticket sales were below the break-even point for many events. Atlanta Chapter put on a great show despite the low turnout.

- The Board approved a change to the Convention Manual to allow the Society to loan money to host chapters after the convention as well as before. This revision did not in itself authorize any loans, which would be considered in the future on a case-by-case basis.

- Because of the low response rate to the mass mailing of convention brochures, 1995 Lancaster brochures will be mailed only to Members who request them through a return post card to be included in a future Bulletin issue.

- Planning continues for the 1996 Charlotte convention.
- The NCC is still calling for bids for 1997-1999.

In other matters: A charter was presented to representatives of the new Carolina Clinchfield Chapter. There were no major developments on insurance for the libraries, with our staff continuing to work on the inventory and the insurance carrier still digesting the partial inventories already sent in. A travel policy is being developed to standardize practices among people who travel on Society business. Dick Davis demonstrated some work in progress on a series of public service announcements which will promote the Society and its services. Several films and videos have been added to the library collection, as well as a collection of print negatives from member Jim Scribbins.

"We're already hauling over the tracks through an agreement with Weyerhaeuser," said Boeing spokesman Mike Tull. "Boeing will haul at least one or two cars of aluminum a week in the form of raw materials for wing modules."

The city manager's office has recommended Gray Line of Seattle and Tacoma, owned by Holland America Line-Westours, and Lewis & Clark Railway of Clark County as operators of the passenger and freight service. Lewis & Clark president Ed Berntsen, a 34-year railroad veteran, foresees strong longterm freight income.

"We intend to be running freight this fall and passengers by summer of '97," Berntsen said. "It'll be a challenge to keep freight going the first six months or year, until infrastructure is in place, like loading and unloading spurs. But we already have the potential to haul feed, lumber, veneer, scrap and recycled products and rock products. We'll connect to both Burlington Northern and Union Pacific to go all over the country."

Berntsen says Tacoma Eastern offices already are being opened at Freighthouse Square, which will be the Tacoma passenger terminus. Freighthouse Square owner Keith Stone finally sees the train he's been waiting for pulling into his station.

"This already is our first year in the black, and this train will help the whole Dome District quite a bit more," he said. "I've been waiting eight years for this. When I first bought the building, they told me this train would be coming 'round the bend any day.

"I already was going to build a 500-foot loading platform for the Sonics Express for this fall, and we'll be able to use for the Train to the Mountain, too."

It isn't exactly a bullet train, but Tacoma's Train to the Mountain might now have climbed its steepest grades and, for the first time, truly be gaining speed.

WEST SIDE SLOW ORDER

Willamette & Pacific Railroad

Robert Melbo reports the Willamette & Pacific Railroad has been struggling to maintain their West Side rail line up to Federal Railroad Administration Class 2 standards, which allows a maximum 25 mph speed of operation. The recent winter and spring weather, along with heavy tonnage over the line, has resulted in substantial tie deterioration. The condition of the ties, at first, did not appear to be that bad, but as usual, looks can certainly be deceiving.

The FRA went over the line on June 2, and placed the entire 21 miles between Independence and Whiteson into "FRA Excepted Track" category. This translates into a limit of 10 mph on that segment.

The tie gang has been temporarily relocated from the Toledo line to the West Side line to replace many ties, dump ballast, and resurface the line. They will then resume work on the Toledo line. The work should be completed as you read this.

Special Note from the Editor
