### FALL BOARD OF DIRECTORS MEETING-HUNTINGTON, WEST VIRGINIA ' NOVEMBER 8-10, 1996

Prior to the official meeting, several rail related events were held. The first of these was a seminar on "Possibilities of Running Amtrak Excursions", given by Don Maxwell, Trip Director. He stated the current Amtrak attitude is to turn down off line trips. A new marketing office has been opened to handle nation wide excursion requests. They hope to eventually have a separate train set dedicated to excursions. They are even interested in running steam excursions, even though they are expensive to operate. He urged getting an early start in making plans for any excursion. Do not wait for a completed contract before marketing a trip. It is preferable to negotiate terms of an excursion lease on a face to face basis, rather than by mail or phone. Make sure that food caterers and suppliers are approved by FDA.

First stop on our Saturday tour was the ACF plant. This plant covers 34 acres, contains 3 miles of track, and employees 450 workers. Their main product now is a center flow covered hopper car. They complete a new 35 ton car every 76 minutes. Second tour stop was the Ohio River Co. coal terminal. Here they empty loaded gondola cars by turning them upside down and dump the coal onto a conveyor belt where it is carried to barges in the river. They dump each car in less that two minutes, compared to six minutes if they used the bottom hoppers. A heated shed is nearby to thaw frozen coal from the sides of the cars in winter. This terminal has a capacity of 5.5 million tons of coal per year. Third stop was to the C & 0 Business Unit office and museum. The last Saturday event was the banquet where we were entertained by a string quartet. The program was a monologue by a local citizen playing the part of Collis P. Huntington, RR magnate who bought the C & 0, played a part in developing the western railroads, and founded the city of Huntington.

An informal Saturday work session was held to discuss some of the issues before the Board, but no action could be taken until the official meeting. First item was a report from the General Counsel that because of an oversight, the Society's Maryland Corporation license has been inactive since 1974. Steps are being taken to pay the back fees and renew this license. The membership records system is now back on line in the Philadelphia office. Renewal notices are to be sent to each Chapter very soon. Monthly statistical updates are to be sent out. The new procedures will save \$1,000 on postage. A request was made for feedback on the Bulletin, since that is the biggest single budget expense.

The official business meeting was called to order by President Greg Molloy on Sunday, Nov. 10, 1996, and opened with invocation given by Harold Walker. Three new National Directors were approved and introduced. Several Presidential appointments were made and announced. In his report, the President thanked the Collis P. Huntington Chapter for hosting this Board meeting and making all the arrangements. The President mentioned two recent deaths to Board members. Membership records are now completely transferred to Philadelphia so the Society can move forward.

LeRoy Dietrich recognized the Central New York and Midwest Chapters for having celebrated their 50th anniversaries, and the New Orleans and Tampa Bay Chapters for 25 years. Robert Eastwood reported the arrangements with Circular Advertising for mailing Bulletins has been changed to Commonwealth Mailing Service at a considerable cost savings. The new Bulletin envelopes are white, and it was hoped members would not mistake them for junk mail and toss. The Library in the Philadelphia office has been reorganized making handling easier. Robert Pinsky reported on improved Membership Development procedures. There are now over 16,000 primary members, and 3,300 family members. 2,600 failed to renew in 1995. The 1997 renewal notices were to be sent out the next week. A grace period was going to be granted for those who did not renew last year in order to maintain their continuity of membership. He urged the Chapter Presidents to send a letter to delinquent members inviting them to renew. Dick Davis, VP PR, sent a note in lieu of a report explaining that he was unable to attend due to recent surgery to remove two moles that were diagnosed as melanoma. He explained the degrees of seriousness, and hoped his had been discovered soon enough. He urged everyone else who had any suspicious looking moles to have them examined. This was followed by a report from Secretary Dave Ackerman on the work session held earlier.

Frank Tatnall, Editor, stated the combined issue 5 & 6 Bulletin to be mailed in December will contain a preregistration form for the 1997 Salt Lake City Convention. Bob Vittitow, Director, Operation Life-Saver had distributed his written report. The number of grade crossing incidents for the first six months this year is down slightly compared to 1995. Trespassing incidents have increased at an alarming rate, and could become a bigger problem than grade crossings.

President Molloy gave a brief report on the RVP meeting. It is hoped to improve communications between the Chapters and National. The RVP's are working with the Boy Scouts in the Railroad Merit Badge qualifications, and also the Heritage Grants Program. Terms and conditions for the grant applications will be sent out in January.

Dr. Cude, Associate Director of Chapter Development presented a Charter request from the Perryville, MD Chapter which was approved by the Board. Joe Heffron, Finance Committee gave a report and asked for budget approval.

Richard Shulby gave a preliminary report on the 1996 Convention at Charlotte. He presented a \$4,000 check to President Molloy as a share of the proceeds. Preregistration forms for the 1997 Convention in Salt Lake City were distributed. Several changes have been made in tours due to the policy change of the UP. Tuesday, June 24 will be a steam trip on the Heber Valley RR. Wednesday, June 25 will be a bus trip to Ely, NV., then a steam trip on the Nevada Northern RR. Thursday, June 26 will be a trip to the Golden Spike National Monument at Promontory Summit, followed by a visit to the Ogden Museum. Friday, June 27 will be reserved for Educational Seminars. A Saturday trip is still being considered. There will be no UP or Amtrak excursions. Several spouse and family activities are being planned. The 1998 Convention will be July 8-12 in Syracuse, New York.

The Pacific Northwest Chapter will host the next Board meeting April 4-6, 1997 in Portland. Printed invitations and Portland brochures were distributed to each place at the delegate tables. Tours will tentatively be Friday afternoon on the Willamette Shore Trolley, Saturday on the Mt. Hood Railroad, and Sunday afternoon on the westside MAX construction project into the tunnel. A Board meeting work session may be Saturday afternoon, and the official Board Meeting will be Sunday morning.
