

To the Sea by Rail

Traveling to Seaside and Astoria on the Spokane, Portland and Seattle Railway

-from The Sounder, Sept., 1996

In the Seattle area, when the summer heat becomes too much, a number of people go to the coast for cooler conditions. This is also true in the Portland area when people make the drive to the beaches around Astoria and Seaside. Up until January 15, 1952 it was possible to make this trip on an SP&S passenger train. Originally passenger business was light, but in 1915 this increased with the creation of the Great Northern Pacific Steamship Company.

Jointly owned by the Great Northern Railway and Northern Pacific Railway this company operated two steamships, the Great Northern and the Northern Pacific, from a dock at Flavel, near Astoria, with ships sailing for San Francisco and also points in Hawaii. In March 1915 service started with departures from Portland on the SP&S Steamer Express on Tuesday, Thursday and Saturday, with arrival in San Francisco the next day. Steel passenger cars were purchased for use on trains 33 & 34. Traffic at first was brisk but by November it was slow enough to warrant one ship on the route. The sum-

mer of 1916 was busy but it soon became apparent that the line was losing too much money and a buyer for the ships was quietly sought. The problem was solved in 1917 when the United States commandeered the two ships as troop transports for World War I. After the closing of the steamships the steel passenger cars were used elsewhere on the SP&S.

Traffic for the beach resorts in the 20's was good, with 8 trains daily between Portland and Astoria in the Summer of 1924. Train schedules usually had four trains daily most of the year with six trains during the summer months. The automobile and busses continued to take their toll and business suffered with the final trains in 1952. The collection at Snoqualmie has several cars that were used on this run, such as wood coaches #213 & #218, wood observation #556, steel coaches #272, #275 & #276 (#272 was a coach before converted to combine #272).

CHAPTER BUSINESS

<u>PNWC-NRHS</u> <u>BOARD MEETING</u> <u>12 September, 1996</u> <u>SUMMARY of MINUTES</u>

Call to Order: President Bob Terkelsen called the meeting to order at 7:15 P.M. Present included Terkelsen, Larson, Johnson, Ordway, Mack, White, Hickok, & Rodabaugh. President Terkelsen welcomed board members.

Reading of Minutes: The minutes of the 8/8/1996 board meeting and 8/16/1996 membership meeting were provided to board members in advance of the meeting. Some minor corrections were offered, and the minutes were approved as corrected.

National Director's Report: Bob Terkelsen reported that a letter has been received from National regarding 25-year pins for three of our members of record. We will present the pins to the persons involved after the pins are received from National. A letter from Rich Carlson to Tri-Met regarding activities associated with the Spring '97 board meeting in April was discussed.

Treasurer's Report: Maxine Rodabaugh reported the account balances. We have received proceeds from the Swap Meet. Charitable activities report to State of Oregon is being submitted. Insurance will be due next quarter.

Standing Committee Reports

Excursions: Ralph Johnson reported that 91 seats have been sold for the October trip as of 9/10. The response to the newspaper advertising has been good. 12 car hosts have been requested, and letters will be going out to qualified persons soon. George Hickok reported that after several phone calls to Amtrak, the equipment for the trips to Corvallis is not available. The cost for the trip has also not been set, but will be reported to the board at a future date as a point of information. As reported in The Trainmaster, the last run of the Pioneer will be on November 4, unless Amtrak funding changes. (Actual stop date is Nov.10, according to Amtrakeditor.)

Rolling Stock: George Hickok reported that work is in progress to prepare the 6200 & 6800 for use by the W&P later this month. The cars will be used for the W&P employees' picnic. A number of problems have been fixed, and much work remains. Time is running short, and more help is needed. Some additional work has been done on the locomotives at Terminal 4. The railroad has broken the string. and provided room around the locomotives so the body can be raised. Pete Rodabaugh is concerned that with the condition of the wheels and bearings, we may not be able to move the equipment. The 700 group has still not been able to find a location to store their equipment. The secretary has been ill, and has not yet acted on the boards direction regarding the COTS on the 6800 (Red River). A draft of a letter was circulated, and approved, and will be sent soon. Maxine Rodabaugh reported that there have been additional discussions with SP regarding the repair to the 3300..

Activities: Darel Mack reported that the Picnic at Brooks served 104 people, and netted a tidy sum. Feedback from the persons who attended from the other organizations was very positive. Things are all set of the Spaghetti dinner on 9/20. Maxine Rodabaugh will be handling the health inspection. Setup will start at 3:00 P.M., with dinner at 6:00 P.M., and program to follow.

Library: Ralph Johnson & Jim Loomis reported that the committee needs additional people to help with various activities. The wiring for the new air conditioner for Room 1A has been requested, but no date yet on when the wiring will be completed.

Concessions: Marilyn Edgar reported that new bumper stickers have been obtained. We may get some materials related to the 3203. (The board suspended temporarily while the Finance committee held an emergency meeting, and recommended to the board approval of funds for purchase of concession stock for the October trip. The board then resumed.) Per recommendation of the Finance committee, MSC Mack/Ordway for purchase of concession stock, not to exceed a set amount, for the October trip. The chapter has received a donation of about 15 signed and numbered prints from artist Jon Darting.

Membership: Ralph Johnson reported that a handout package for perspective members will be available for the October trip. Please discard any membership applications that you have on hand - the information on the form is no longer correct. Note that National has increased dues by \$3.00 per year. Maxine Rodabaugh reported that a printout has been received from National, and there are a number of errors that are being corrected. There was considerable discussion regarding an increase in Chapter dues for next year. In accordance with the bylaws, such an increase will have to be announced at the October meeting, and be voted on by the membership at the November meeting. MSC Johnson/Ordway to increase chapter dues by \$2.00 per year. Trainmaster: Jim Loomis reported that the current issue has been mailed. Bob Terkelsen will talk with Tammy Auberg regarding help with The Trainmaster.

Museum: Glenn Laubaugh reported that OMSI has expressed interest in a possible display of museum materials. Additional work and support will be needed before this can actually happen. Persons interested in contributing to our Internet web site should contact Glenn Laubaugh for additional information. We have received permission to use several drawings from Dave Stimac. It is not clear how these might be used, although a number of ideas were discussed.

Programs: September will be Al Viewig with Operation Lifesaver (actually, *Everett Cutter-editor*). October will be Rich Parks. Additional programs are needed: contact Bob Terkelsen if interested.

Old Business

Brent Larson reported on the situation with the Nominating Committee. Bob Terkelsen reviewed the election process as specified in the bylaws. (The current list of candidates will be published in the *{October} Trainmaster*.) Ralph Johnson reported back on the movie screen at the church. The screen is very old, and repair may not be an option. Johnson will be contacting suppliers in the near future, and

Amtrak Honors Portland Station Agent for Sustained Excellence

Scott Hurd is described by many as one of the finest Station Agents in our system. Scott has demonstrated exceptional overall job performance for 17 years. He is hard working and has volunteered countless hours by working on special projects promoting and selling Amtrak in the Pacific Northwest.

Scott began his Amtrak career in 1979 as a Sales Consultant in San Francisco and in 1986 moved to Portland where he became the Station Agent. On his own time, he has coordinated many special events to make the public aware of Amtrak. Scott coordinated the Rail Vacation' Night, which was held at the Portland station with 250 guests in attendance. He contacts and builds relationships with the local news media to promote special events and to keep travelers aware of Amtrak's reliability in adverse weather conditions. Scott set up a booth at the AFL-CIO Labor Day picnic, emphasizing the theme of "Amtrak Salutes the Great American Worker." This event lasted for two days and was attended by hundreds of people. To further ensure that the community is aware of Amtrak's services, Scott also disseminates flyers to group organizers to promote oneday trips to Seattle. He coordinated an equipment display at the Portland station which attracted more than 2,000 people and 100 travel agents. Scott negotiated a proposal with Northwestern Trailways to transport customers from Portland to Spokane on days train #28 did not operate, He contacts schools, churches and scout groups to make presentations - complete with slides - to promote group sales. Scott has worked tirelessly for years promoting Amtrak and sharing his love of rail travel. He is a wonderful example of sustained excellence.

In support of Scott's nomination, a former Amtrak employee adds that "...Scott is one of the most productive, customer-focused employees he has known!" He goes the extra mile to help his customers and leaves an indelible impression on them. Although he has relocated to Portland, his "old accounts" in Indiana still ask about him.

Scott is admired and respected by all who know him, as evidenced by a committee of 21 Union Station employees who signed a letter nominating Scott for a President's Award. The letter told of their respect and admiration for Scott citing, "We feel no one is more deserving of this recognition than Mr. Hurd. His value to Amtrak is quite simply immeasurable."

DICK LLOYD 1926-1996

Charles R. (Dick) Lloyd, NRHS Director of Computer Services, died July 15, 1996 at the age of 70 at his home in Baltimore, MD. Lloyd, a member of the NRHS for 52 years, was instrumental in converting membership records from addressograph plates to computer files in late 1 981 and early 1982. In 1990, fie was officially named Director of Computer Services and served in that capacity until his death.

Lloyd's lifelong love of streetcars began early. By the time he was 12 years old, he had ridden every type of car used on the Baltimore system. During a two-year stint working for the Baltimore Transit Company, he learned how to operate every one of those car-types. After he had seen one streetcar after another converted into a bus line, he quit.

But that was not the end of his enthusiasm for the streetcar. On November 3, 1963, when trolley service in Baltimore made its last run, Lloyd rode one of the last cars into the carbarn. Three years later, Lloyd was instrumental in forming the Baltimore Streetcar Museum. He remained active with the museum, serving in various capacities, throughout the years. At the time of his death, Lloyd was the museum's vice president of operations, dispatcher and training instructor. According to a spokesman at the museum (Andrew S. Blumberg), "He actually used Baltimore Transit Company rules, which made our operations authentic right down to the buttons on the uniforms." He is credited with 25 years of accident-free operations.

Born and raised near Baltimore, Lloyd was the son of W. S. Lloyd, owner of Lloyd's Hobby Shop. He worked in the mailroom of the Baltimore and Ohio Railroad before entering the U. S. Navy in 1943 and serving in the Pacific theater. Upon completion of his active military service, Lloyd served in the active reserves, retiring with the rank of Chief Warrant Officer.

After discharge from active duty and the death of his father, Dick took over the family hobby shop. Later he sold the hobby shop and formed Lloyd Publicity Company, a printing, computer and direct-mail firm. It was during this latter tenure that he was instrumental in helping bring the NRHS from the addressograph to the computer age. After selling his business a year ago, Lloyd remained as a consultant to the Society.
